Director Wooldridge indicates that she is not in favor of any play on City fields with the notion of "play then repair". She prefers cancellation; in emergency, she prefers play to be moved to Atlantic and/or Hornet field.

ASC agrees to compensate for repair of Lincoln field not to exceed \$2300 for All Star game repairs.

- ASC has refined who we are by making the recreational side fun and develop skills provincial and community based program
- The Club is doing a balance act at the moment
- When you look at what's coming out of NorCal, we want to try to set our sites on this, however, does this work with an age-pure system?
- There are guidelines out there and available to follow and implement for our players
- We don't have the structure that Bay Oaks has which is why kids go there
- We don't have coaches under a 'Coach Director' to have all coaches working together
- Select soccer is different than Recreational soccer they are a 'Gold' level
- ASC has an evaluation process in place
- Migrating out of CYSA to NorCal (two years now)
- Must be sensitive to the needs of the kids and the game keep the game fun
- Need to have sub-lease signed for Alameda Point

Treasurer's Report

The main outflows since the last meeting include \$7570 to Shooting Stars for our fall pictures, \$6320 to ARPD for the fall field usage fees, and about \$2300 to Alameda Awards and Recognition for all star tee-shirts and the President's awards. We currently have net worth of \$73,792. We wrapped up purchasing the of commercial liability insurance for our activities at Alameda Point. The additional premium will cost us \$566 per annum, which is prorated to \$384. The insurance will need to be renewed on our regular cycle in August of 2013 (along with the Hornet insurance and the D/O coverage).

Reasons are for a normalized and transparent process for allocation fields for practices, which will enable field requests a fair and equitable review and vetting process that includes the vice presidents and if necessary the

No expected additional costs - will require 1st and 2nd VPs to engage in the review of 2nd and 3rd request options.

Preamble:

When I was Field Coordinator, Competitive teams started practicing earlier than Recreational teams, so they got their field/time allocations sooner. Other than that, I'd have a difficult time rationalizing or advocating as to why Competitive coaches and teams should have priority over recreational coaches and teams.

Here's why: we want to have the most number of coaches/teams satisfied with field/time allocations to their 1st or 2nd choices. To that end, there are more Recreational coaches/teams to slot. It's a numbers issue - the most good for the most teams/players.

To state in policy that Competitive coaches and teams should have field allocation priority over Recreational coaches and teams would create some serious divisions and issues for many.

I'd suggest that the 1st and 2nd VPs are the ones who are on the Field Allocation Review group and at all complaints or issues around field allocations are delegated to these two positions for resolution, since they are jointly responsible for administrative and operational club functions. The president can and should help only if there's an impasse that can't be resolved by the Field Coordinator and these two VPs.

Field Request\Allocation Process:

- 1. Field Coordinator submits request to ARPD for fields based on previous season\previous year's field allocation needs. This request should also identify and represent the various locations on the Island (South, Mid, North) and age groups.
- 2. Field Coordinator identifies which fields will be used for which age group primarily based on largest fields used for oldest age groups. During Coach Registration, coach indicates 1st, 2nd and 3rd choices for Island location (South, Mid, North), Days of the Week (M, Tu, W, Th, F) and Time Frames, (4:00-5:00, 5:00-6:00, 6:00-7:00)
- 3. Registrar (Thu-Huong) provides Coach spreadsheet that details these requests along with age group, email and phone number information.
- 4. Field Coordinator aggregates the requests by age group, then sorts by 1st, 2nd and 3rd choices.
- 5. Field Coordinator flags (prioritizes) requests of coaches that are:
 - a. Coaching more than one team
 - b. Coaching and Refereeing
 - c. Coaching and Volunteering (Picture Day, 4th of July, Tournament, Field Steward, Board of Directors)
- 6. Field Coordinator references ARPD permits to create a template for each field that details available time slots.
- 7. Field Coordinator works through the 1st choice requests of the flagged coaches referenced in step #5 above.
- 8. Once these requests have been slotted to field\time slots, Field Coordinator works through remaining coaches 1st choice requests and slots to field\times as possible.
- 9. For any outstanding requests, Field Coordinator works through 2nd choice requests and slots to field\times as possible.
- 10. For any outstanding requests, Field Coordinator works through 3rd choice requests and slots to field\times as possible.
- 11. Any outstanding requests will be slotted to any remaining field\times left.
- 12. Once this work has been completed, Field Coordinator provides draft to Field Allocation Review group (should

be at least 2 Executive Board members, both 1st VP -Administrative and 2nd VP-Operations and possibly the President).

- 13. Field Coordinator and Field Allocation Review group meet to discuss:
 - a. The ARPD Field Permits and Field Templates
 - b. The Field Coordinators Field-Age Group identifications.
 - c. The Coaches request spreadsheet
 - d. The field\time allocations for each coach\team.
 - e. Specific focus of the review should be on coaches who were provided 3rd choice and left-over field allocations.
- 14. Field Coordinator and Field Allocation Review group will discuss options or work-around solutions that might help 3rd choice and left-over field allocation coaches\teams.
- 15. Field Coordinator and Field Allocation Review group finalize and approve the field\time allocations together.
- 16. Emails are sent to the left-over field allocations coaches advising them that it was not possible to meet their choices this season and advising of any potentially open slots that they could use.
- 17. Field Coordinator creates ASC\ARPD field permits as per finalized and approved.
- 18. Field Coordinator provides ASC\ARPD field permits to coaches.
- Lots of thought goes into getting field permits
- The idea is to be consistent from season to season
- Lets all see how this is done and set it up for a self-help on our website so coaches can select their choices
- We have Select and Recreation coaches
- We are trying to do the most good for the most people
- Coaches put in the comments in Sportability as to what field times/days they are requesting
- As a Board, we talked about acknowledging or giving a priority to those that volunteer
- For the third choice, field/times are provided as it is possible
- If coach isn't happy with third choice, we can provide what is left over for them to choose from
- Time change is always an issue is it possible to open another field up? Lights at Hornet and Alameda Point should help with this a lot.
- Lights on the field are the only solution
- As we approach daylight savings time, all teams rotate about 30 minutes to an hour

[Motion 2] Adopt updated process for assignment of Field Practice times and locations as per description subject to the following amendment and to include President at their discretion to field review group. Section 12 to include Alameda Islander priority placement when possible. The 1st and 2nd Vice Presidents are the ones who are on the Field Allocation Review group, and all complaints or issues around field allocations are delegated to these two positions and the President for resolution since they are jointly responsible for administrative and operational Club functions. The President can and should help only if there's an impasse that can't be resolved by the Field Coordinators and these two Vice Presidents.

Discussion -

- It is not a good idea to say 'Select gets priority over Recreational'
- Should have a memorialization of early placement in this document
- John Orla-Bukowski to include the 'where's and why's'
- Once all rules have been decided and set, program can be written to be able to override the system
- When time change shift happens, have early team practice late and late practice early
- Field Coordinators will need to keep slots open in the lighted fields for those coaches that are not able to leave work and be in Alameda any sooner than they are available

All,

During the recent field request process and Rec and Parks commission meeting to proposal hourly rates for field use, there will be more administrative requirements for field use and interactions with ARPD.

This means more requirements on the competitive teams and more volunteer hours.

I would like to add to the field review and allocation process the requirement for 1 or 2 individuals from the competitive teams to act as administrators to help put in 20-40 hours during the fall and spring periods to support these new requirements.

Peter, we should add these requirements since the competitive teams also use the fields 30% more than the recreational teams and thus will incur 30% more cost to the club.

This site is the former Alameda Beltline Railroad property. It was secured by the City at a very low price, far below market value, due to the dedication and advocacy efforts of Jean Sweeney with the intention to use it for recreational purposes only. This site extends from Constitution Way and Atlantic Avenue (by the Alameda Food Bank) to Sherman Avenue, by the old building that once served as the Alameda Beltline headquarters.

According to Alameda Recreation and Park Director Amy Wooldridge, "It is remarkable to have this large of a site available for new park development in an urban area. Now is the time for Alamedans to design this significant and historical space from its inception." By comparison, Lincoln Park is 7.8 acres, Longfellow Park is only 1.14 acres and the City portion of Washington Park is 14.7 acres.

The City wants to gain insight and understanding of the community vision for the park to begin design and development of the Beltline area. There are lots of ideas about the types of uses that should be located on this site such as community gardens, wildlife habitat, playgrounds, and sports fields. It could be developed as a very passive park, more active park uses or a combination of both, based on community need and funding opportunities.

The community feedback will be compiled and presented to the Recreation and Parks Commission on March 14th for the Commission's final recommendation for City Council's review. For more information on the Alameda Beltline development, visit www.cityofalamedaca.gov/Recreation.
